

Franchise Cost: \$200,000 - \$350,000* plus applicable taxes.

Additional Working Capital: (start-up costs) \$45,000

The exact cost of a Mac's Sushi franchise will depend upon location, and whether it is a kiosk or an in-line store.

Included in the cost of a franchise is the following:

- Standard equipment, furniture, branded display materials, and signage
- Training program for one week at our Yorkdale location
- A store or kiosk opening crew to promote smooth operation in the initial stages
- The use of all Mac's Sushi menus, display tablets and pricing information, uniforms, and caps
- The right to use trademarks and trade names
- Ongoing support from head office personnel regarding the food service business

Not included in the cost of the franchise:

- All legal services
- Agents costs and disbursements

Selection Process

- Completion of our <u>Franchise Application Form</u> with all relevant data, previous experience, and banking/financial information proving net worth
- Formal meeting between applicants and head office personnel
- Extensive interview/approval process

To Submit an Application

When evaluating an applicant, we consider many characteristics of potential candidates. Aspects we assess include: the franchisee's planned structure of ownership, level of commitment, proven work ethic, past employment and managerial experience, the ability to communicate effectually, and proven financial stability.

Like any small business, being a Mac's Sushi franchisee demands commitment and, especially early on, a large time investment. Franchise agreements are granted for a term of approximately 10 years, so candidates must be aware that operating a franchise is a long-term commitment.

Typically franchisees are a team of two people who each commit full-time to the success of their Mac's Sushi location. Though teams of two are usual, individual franchise owners planning to hire adequate staff will be considered. "Full-time" by our definition, means that individuals have no external employment. As such, all partners must be financially responsible for the business.

To begin the process of becoming a Mac's Sushi franchisee, candidates must complete the attached <u>Franchise Application Form</u>. The completed questionnaire must be submitted to Mac's Sushi head office for consideration.
